साथीदारांनी परिसरात राहणाऱ्या ईश्वरी शाहूला खड्ड्यातून रोहितचा मृतदेह काढण्यासाठी बोलवावेत. त्याने नकार दिला असता जबर मारहाण केली. वस्तीतील लोकांनाही धमकावले. त्याच्यामुळे त्रस्त लोकांचा धीर सुटला. त्यांनी भुरू टोळीवर हल्ला केला. लबर मारहाण करण्यात आली. या हल्ल्यात सुटका भाऊ इकबाल याचा मृत्यू झाला. मात्र भुरू आणि इतर आपला जीव वाचवून पसार होण्यात यशस्वी झाले. या घटनेनंतर रोहित हत्याकांडाचा खुलासा झाला होता.

नागपूर: सलग एक दशक वसंतराव नाईक झोपडपट्टीत दहशत फसरवणाऱ्या भुरू उर्फ शेख अकरम शेख रहमान आणि पप्पू उर्फ कमलेश द्वाकाप्रसाद गुप्ताला मोक्षाच्या विशेष न्यायालयाचे न्यायाधीश एम. एस. आझमी यांनी रोहित जैन हत्याकांडात दोषी ठरवून जन्मठेपची शिक्षा सुनावली आहे. या प्रकरणात इतर चार आरोपींवर आरोप सिद्ध न झाल्याने त्यांची सुटका करण्यात आली. सुटलेल्या आरोपींची नावे अनूप अण्णा भोसले, भास्कर ऑस्टिन जोसेफ, सचिन केसरसिंग ठाकुर आणि विशाल नारायणस्वामी रेड्डी आहेत. सर्वोपर लखनौदीन, सिवनी येथील रोहित उर्फ श्रीपाल जिनेंद्रकुमार जैन (३५) च्या खुनाचा आरोप होता. आरोपींची गुन्हेगारी पार्श्वभूमी पाहता पोलिसांनी त्यांच्यावर मोक्षाही लावला होता, मात्र मोक्षातून सर्वांची सुटका करण्यात आली.
